Proposed Issuance of Clean Air Act Permit Program (Title V) Permits to
Allied Waste Central Region, Morris and
Morris Genco, LLC in Morris

Allied Waste Central Region has requested a Clean Air Act Permit Program (CAAPP) permit from the Illinois Environmental Protection Agency (Illinois EPA) for air emissions from the landfill located at 1800 Ashley Road in Morris. As a major source of air emissions, the company is required by the 1990 Amendments to the Clean Air Act to obtain a CAAPP permit. The permit will be enforceable by the United States Environmental Protection Agency, as well as the Illinois EPA. The beginning of this public comment period also serves as the beginning date of the USEPA 45 day review period, provided the USEPA does not seek a separate proposed period. This permit may contain terms and conditions established pursuant to Title I of the federal Clean Air Act thereby making it a combined CAAPP and Title I permit.

Morris Genco, LLC has requested a Clean Air Act Permit Program (CAAPP) permit from the Illinois Environmental Protection Agency (Illinois EPA) for air emissions from the landfill gas combustion processes at the Allied Waste Central Region Landfill located at 1800 Ashley Road in Morris. As a major source of air emissions, the company is required by the 1990 Amendments to the Clean Air Act to obtain a CAAPP permit. The permit will be enforceable by the United States Environmental Protection Agency, as well as the Illinois EPA. The beginning of this public comment period also serves as the beginning date of the USEPA 45 day review period, provided the USEPA does not seek a separate proposed period. This permit may contain terms and conditions established pursuant to Title I of the federal Clean Air Act thereby making it a combined CAAPP and Title I permit.

The landfill and the landfill gas combustion process are considered a single source for determination of CAAPP applicability. The Illinois EPA is accepting comments on the draft permit.

Comments are requested on the proposed issuance of the permits. Comments must be postmarked by midnight March 9, 2002. If sufficient interest is expressed in a permit, a hearing may be held.
