Proposed Renewal and Revision of the Clean Air Act Permit Program
Permit for

Afton Chemical Corporation in Sauget

Afton Chemical Corporation has requested that the Illinois Environmental Protection Agency (Illinois EPA) renew the Clean Air Act Permit Program (CAAPP) permit regulating air emissions from its organic chemical manufacturing facility located at 501 Monsanto Avenue in Sauget. The CAAPP permit is also being revised to memorialize the negotiated resolution of the initial CAAPP permit appeal. Based on its review of the application, the Illinois EPA has made a preliminary determination that the application meets the standards for issuance and has prepared a draft permit for public review.

The Illinois EPA is accepting comments on the draft permit. Comments must be postmarked by midnight March 7, 2009. If sufficient interest is expressed in the draft permit, a hearing may be held. The CAAPP is Illinois' operating permit program for major sources of emissions, as required by Title V of the Clean Air Act (Act). The conditions of CAAPP permits are enforceable by the public, as well as by the USEPA and Illinois EPA. In addition to implementing Title V of the Act, CAAPP permits may contain "Title I Conditions," i.e., conditions established under the permit programs for new and modified emission units, pursuant to Title I of the Act. This permit contains T1 conditions in sections 5.5.3, 7.1.6, 7.3.6, 7.8.6, 7.9.6, 7.10.6, 7.11.6, 7.12.6, 7.13.6, 7.14.6, 7.15.6, 7.16.5, 7.16.6, 7.17.6, 7.18.6, 7.19.6, 7.22.5, 7.22.6, 7.24.6, 7.25.6, and 7.27.6 that were established in previously issued permits. The permit contains T1 conditions in section 5.5.3 that are being newly established in this permit. The permit contains T1 conditions in sections 5.5.3, 7.1.6, 7.9.6, 7.10.6, 7.11.6, 7.16.6, and 7.17.6 that are being revised by this application.
