**Notice of Public Comment Period and Hearing  
Proposed Issuance of a Clean Air Act Permit Program Permit  
Automotive Robotics Proving Lab in East Peoria**

Automotive Robotics Proving Lab has requested a Clean Air Act Permit Program (CAAPP) permit from the Illinois Environmental Protection Agency (Illinois EPA) to regulate air emissions from its engine test cells located at 5 Altorfer Lane in East Peoria. Based on its review of the application, the Illinois EPA has made a preliminary determination that the application meets the standards for issuance and has prepared a draft permit for public review. The Illinois EPA is holding a public comment period and a hearing to accept comments from the public on the proposed issuance of the permit prior to making final decisions on the application.

**The Illinois EPA will hold a public hearing on Wednesday, June 19, 2013 at 7:00 pm at the Fon du Lac Park District Administration Center, 201 Veterans Drive in East Peoria.** The hearing will be held by the Illinois EPA to receive comments and answer questions from the public prior to making a final decision concerning the draft CAAPP permit. The hearing will be held under the Illinois EPA's "Procedures for Permit and Closure Plans," 35 IAC 166, Subpart A. Lengthy comments and questions should be submitted in writing. Requests for interpreters (including sign language) must be made by June 5, 2013. The Illinois EPA will accept written public comments on the draft CAAPP permit during the comment period. The comment period will remain open from Sunday, May 5, 2013, through Monday, July 19, 2013. **Written comments must be postmarked no later than midnight Monday, July 19, 2013 unless otherwise specified by the Hearing Officer.**

The CAAPP is Illinois' operating permit program for major sources of emissions, as required by Title V of the Clean Air Act (Act). The conditions of CAAPP permits are enforceable by the public, as well as by the USEPA and Illinois EPA. In addition to implementing Title V of the Act, CAAPP permits may contain "Title I Conditions," i.e., conditions established under the permit programs for new and modified emission units, pursuant to Title I of the Act. The permit

contains T1 conditions in section 3.3, 3.4 and 4.1.2 that were established in previously issued permits. The permit contains T1 conditions in section 3.4 that are being revised by this application. The permit contains no T1 conditions that are being newly established by this application.
