This permit is hereby granted to the above-designated Permittee to OPERATE emission source(s) and/or air pollution control equipment consisting of two paint booths with individual dry filters pursuant to the above-referenced application. This Permit is subject to standard conditions attached hereto and the following special condition(s):

- 1a. This federally enforceable state operating permit is issued to limit the emissions of air pollutants from the source to less than major source thresholds (i.e., 100 tons/yr for VOM, 10 tons/yr for a single HAP and 25 tons/yr for combined HAPs). As a result, the source is excluded from the requirement to obtain a Clean Air Act Permit Program (CAAPP) permit. The maximum emissions of this source, as limited by the conditions of this permit are described in Attachment A.
- b. Prior to issuance, a draft of this permit has undergone a public notice and comment period.
- c. This permit supersedes all operating permit(s) issued for this location.
- 2a. Operations and emissions from the coating operations shall not exceed the following limits:

- b. Coatings, as applied, including thinner or makeup solvent, shall not exceed 3.5 lb of VOM per gallon of coating pursuant to 35 Ill. Adm. Code 215.204(j).

- c. The emissions of HAPs as listed in Section 112(b) of the Clean Air Act shall not equal or exceed 10 tons per year of any single HAP or 25 tons per year of any combination of such HAPs, or such lesser quantity as USEPA may establish by rule which would require the Permittee to obtain a Clean Air Act Permit Program permit from the Illinois EPA. As a result of this condition, this permit is issued based on the emissions of any HAP from this source not triggering the requirement to obtain a Clean Air Act Permit Program permit from the Illinois EPA.
- d. Compliance with annual limits shall be determined on a monthly basis from the sum of the data from the previous month plus the preceding 11 months (i.e., a 12 month running total).
3. This permit is issued based on negligible emissions of particulate matter the coating operations. For this purpose, emissions shall not exceed nominal emission rate of 0.1 lb/hour and 0.44 ton/year.
4. In the event that the operation of this source results in an odor nuisance the Permittee shall take appropriate and necessary actions to minimize odors, including but not limited to, changes in raw material or installation of controls, in order to eliminate the odor nuisance.
- 5a. The Permittee shall maintain records of the following items:
 - i. Usage of each coating and solvent (gal/mo and gal/yr);
 - ii. VOM and HAP content of each coating and solvent (lb/gal or wt. %);
and
 - iii. VOM, single HAP and total HAPs emissions (ton/mo and ton/yr).
- b. All records and logs required by this permit shall be retained at a readily accessible location at the source for at least three years from the date of entry and shall be made available for inspection and copying by the Illinois EPA and USEPA upon request. Any records retained in an electronic format (e.g., computer) shall be capable of being retrieved and printed on paper during normal source office hours so as to be able to respond to the Illinois EPA request for records during the course of a source inspection.
6. If there is an exceedance of the requirements of this permit as determined by the records required by this permit, the Permittee shall submit a report to the Illinois EPA's Compliance Section in Springfield, Illinois within 30 days after the exceedance. The report shall include the emissions released in accordance with the recordkeeping requirements, a copy of the relevant records, and a description of the exceedances or violation and efforts to reduce emissions and future occurrences.

7. Two (2) copies of required reports and notifications concerning equipment operation or repairs, performance testing or a continuous monitoring system shall be sent to:

8. The Permittee shall submit the following additional information with the Annual Emissions Report, due May 1st of each year: paint, solvent, and thinner usage. If there have been no exceedances during the prior calendar year, the Annual Emission Report shall include a statement to that effect.

It should be noted that this permit has been revised to specify paints and solvents composition and resulting emissions. This revision does not relax monitoring, recordkeeping, or reporting requirements contained in federally enforceable conditions of this permit. These permit conditions assure that this source would not be a major source for purpose of CAAPP.

Attachment A-Emissions Summary

This attachment provides a summary of the maximum emission from the coating plant, operating in compliance with the requirements of this federally enforceable permit. In preparing this summary, the Illinois EPA used the annual operating scenario which results in maximum emissions from such a plant. This is a usage of 45,500 gallons of paints and 3,495 gallons of solvents per year. The resulting maximum emissions are well below the levels, 100 tons per year of VOM , 10 tons per year of a single HAP and 25 tons per year of combined HAPs at which this source would be considered a major source for purposes of the Clean Air Act Permit Program. Actual emissions from this source will be less than predicted in this summary to the extent that material is handled, coatings used and control measures are more effective than in this permit.
