

Notice of Public Hearing and Comment Period
Concerning Proposed Issuance of a Clean Air Act Permit Program Permit to
the Premcor Refining Group, Inc. – Hartford Distribution Center

The Premcor Refining Group, Inc. has requested that the Illinois Environmental Protection Agency (Illinois EPA) Bureau of Air issue a Clean Air Act Permit Program permit for its Hartford Distribution Center located at 201 East Hawthorne in Hartford. The Hartford Distribution Center is petroleum bulk storage and loading terminal. The CAAPP is Illinois' operating permit program for major sources of emissions, as required by Title V of the Clean Air Act. The conditions of CAAPP permits are enforceable by the public, as well as by the USEPA and Illinois EPA. CAAPP permits may contain new and revised conditions established under permit programs for new and modified emission units, pursuant to Title I of the federal Clean Air Act, thereby making them combined Title V and Title I permits.

The Illinois EPA will hold a public hearing on July 13, 2004 at 7:00 p.m. at the Village of Hartford Recreational Building, 715 North Delmar in Hartford. The hearing will be held to receive comments and answer questions from the public prior to making a final decision concerning the two draft permits. The hearing will be held under the Illinois EPA's "Procedures for Permit and Closure Plans," 35 IAC 166, Subpart A. Lengthy comments and questions should be submitted in writing. Requests for interpreters (including sign language) must be made by June 29, 2004. Written comments must sent to the Hearing Officer and be postmarked by midnight, August 12, 2004, unless otherwise specified by the Hearing Officer. Written comments need not be notarized.
