Proposed Renewal of the Clean Air Act Permit Program Permits for
Multifilm Packaging Corporation in Elgin and
Plastic Decorators, Inc. in Elgin

Multifilm Packaging Corporation has requested that the Illinois Environmental Protection Agency (Illinois EPA) renew its Clean Air Act Permit Program (CAAPP) permit for the air emissions from its printing facility located at 1040 North McLean Boulevard in Elgin. The CAAPP is Illinois' operating permit program for major sources of emissions, as required by Title V of the Clean Air Act. The conditions of CAAPP permits are enforceable by the public, as well as by the USEPA and Illinois. The beginning of this public comment period also serves as the beginning date of the USEPA 45 day review period, provided the USEPA does not seek a separate proposed period. CAAPP permits may contain new and revised conditions established under permit programs for new and modified emission units, pursuant to Title I of the federal Clean Air Act, thereby making them combined Title V and Title I permits.

Plastic Decorators, Inc. has requested that the Illinois Environmental Protection Agency (Illinois EPA) renew its Clean Air Act Permit Program (CAAPP) permit for the air emissions from its automotive knobs and switch parts manufacturing facility located at 1330 Holmes Road in Elgin. The CAAPP is Illinois' operating permit program for major sources of emissions, as required by Title V of the Clean Air Act. The conditions of CAAPP permits are enforceable by the public, as well as by the USEPA and Illinois. The beginning of this public comment period also serves as the beginning date of the USEPA 45 day review period, provided the USEPA does not seek a separate proposed period. CAAPP permits may contain new and revised conditions established under permit programs for new and modified emission units, pursuant to Title I of the federal Clean Air Act, thereby making them combined Title V and Title I permits.

The Illinois EPA is accepting comments on the draft permit renewals.
