Permit is hereby granted to the above-designated Permittee to OPERATE emission source(s) and/or air pollution control equipment consisting of two coating booths controlled by filters pursuant to the above-referenced application. This Permit is subject to standard conditions attached hereto and the following special condition(s):

- 1a. This federally enforceable state operating permit is issued to limit the emissions of air pollutants from the source to less than major source thresholds (i.e., 100 tons/year for volatile organic materials (VOM), 10 tons/year for a single hazardous air pollutant (HAP), and 25 ton/year for totaled HAPs). As a result the source is excluded from the requirement to obtain a Clean Air Act Permit Program (CAAPP) permit. The maximum emissions of this source, as limited by the conditions of this permit, are described in Attachment A.
- b. Prior to issuance, a draft of this permit has undergone a public notice and comment period.
- c. This permit supersedes all operating permit(s) issued for this location.
- 2a. This permit is issued based upon the source has elected to comply with the VOM emission limitations of 35 Ill. Adm. Code Part 215 Subpart F: Coating Operations. Compliance with the requirements of this subpart shall be achieved through the use of coatings complying with VOM content limitation of 35 Ill. Adm. Code 215.204(j)(1) and (j)(2) of 4.3 and 3.5 pounds of VOM per gallon of coating, respectively (minus water and any compounds which are specifically exempted from the definition of VOM), as applied.
- b. This permit is issued based upon the coating lines being exempt from the requirements of 35 Ill. Adm. Code 215.301 per provisions of 35 Ill. Adm. Code 215.209: No coating line subject to the limitations of Section 215.204 is required to meet requirements of Sections 215.301 if the coating line meets requirements of Section 215.204.

3. The VOM usage in the raw materials and VOM emissions from two painting booths shall not exceed 3.0 tons/mo and 24.0 tons/yr.

The VOM(HAP) emissions shall be determined from the following equation on a monthly basis:

$$E = \Sigma (M_i \times C_i) / 2,000, \text{ Where:}$$

E - VOM (HAP) emissions (tons)

M_i - VOM-containing raw material usage (gal)

C_i - VOM content of the raw material (lb/gal)

These limits are based on the maximum production rate. Compliance with annual limits shall be determined from a running total of 12 months of data.

4. The emissions of HAPs as listed in Section 112(b) of the Clean Air Act shall not equal or exceed 10 tons per year of any single HAP or 25 tons per year of any combination of such HAPs, or such lesser quantity as USEPA may establish by rule which would require the Permittee to obtain a Clean Air Act Permit Program permit from the Illinois EPA. As a result of this condition, this permit is issued based on the emissions of any HAP from this source not triggering the requirement to obtain a Clean Air Act Permit Program permit from the Illinois EPA.
5. This permit is issued based on negligible emissions of particulate matter from the two paint booths. For this purpose, emissions from each emission source, shall not exceed nominal emission rates of 0.1 lb/hour and 0.44 ton/year.
- 6a. The Permittee shall maintain daily records of the following items:
 - i. The name and identification number of each coating as applied; and
 - ii. The weight of VOM per volume of each coating (minus water and any compounds which are specifically exempted from the definition of VOM) as applied each day on coating lines.
- b. The Permittee shall maintain monthly records of the following items:
 - i. The name and usage (gal/mo, gal/yr) of each coating and cleanup solvent;
 - ii. The VOM and HAP content of each coating and cleanup solvent;
 - iii. VOM and HAP emissions (lb/mo, tons/yr).
7. All records and logs required by this permit shall be retained at a readily accessible location at the source for at least three years from the date of entry and shall be made available for inspection and copying by the Illinois EPA or USEPA upon request. Any records retained in an electronic format (e.g., computer) shall be capable of being retrieved and printed on paper during normal source office hours so as to be able to respond to an Illinois EPA or USEPA request for records during a course of a source inspection.

8. If there is an exceedance of the requirements of this permit as determined by the records required by this permit, the Permittee shall submit a report to the Illinois EPA's Compliance Section in Springfield, Illinois within 30 days after the exceedance. The report shall include the emissions released in accordance with the record keeping requirements, a copy of the relevant records, and a description of the exceedance or violation and efforts to reduce emissions and future occurrences.

9. The Permittee shall submit the following additional information from the prior calendar year, along with the Annual Emission Report, due May 1st of each year:

Coating and clean-up solvent usage (gal/year).

Attachment A - Emissions Summary

This attachment provides a summary of the maximum emission from a metal parts coating plant operating in compliance with the requirements of this federally enforceable permit. In preparing this summary, the Illinois EPA used the annual operating scenario which results in maximum emissions from such a plant. The resulting maximum emissions are well below levels ,e.g., 100 tons per year of VOM, 10 tons/year of any single HAP and 25 tons/year of a combination of all HAPs, at which this source would be considered a major source for purposes of the Clean Air Act Permit Program. Actual emissions from this source will be less than predicted in this summary to the extent that material is handled, and control measures are more effective than required in this permit.
