This permit is hereby granted to the above-designated Permittee to OPERATE emission source(s) and/or air pollution control equipment consisting of Natural Gas/Propane-Fired Asphalt Plant with Baghouse, 3 Liquid Asphalt and Storage Tanks (24,000, 35,000, and 123,000 Gallons) 3 Hot Mix Storage Silos as described in the above-referenced application. This Permit is subject to standard conditions attached hereto and the following special condition(s):

- 1a. This federally enforceable state operating permit is issued to limit the emissions of carbon monoxide from the asphalt plant to less than major source thresholds, as further described in Attachment A. As a result, the source is excluded from requirements to obtain a Clean Air Act Permit Program permit.
 - b. Prior to issuance, a draft of this permit has undergone a public notice and comment period.
 - c. This permit supersedes the current permit(s) issued for this location.
- 2a. This Asphalt Plant is subject to New Source Performance Standards (NSPS) for Hot Mix Asphalt Plants, 40 CFR 60, Subparts A and I. The Illinois EPA is administering these standards in Illinois on behalf of the United States EPA under a delegation agreement.
 - b. The emissions from the Asphalt Plant shall not contain particulate matter in excess of 0.04 gr/dscf and shall not exhibit 20% opacity or greater, pursuant to the NSPS, 40 CFR 60.92.
 - c. At all times the Permittee shall also maintain and operate the Asphalt Plant, including associated air pollution control equipment, in a manner consistent with good air pollution control practice for minimizing emissions, pursuant to the NSPS, 40 CFR 60.11(d).

- 3a. Pursuant to 35 Ill. Adm. Code 212.123(a), no person shall cause or allow the emission of smoke or other particulate matter, with an opacity greater than 30 percent, into the atmosphere from any emission unit other than those emission units subject to the requirements of 35 Ill. Adm. Code 212.122, except as allowed by 35 Ill. Adm. Code 212.123(b) and 212.124.
- b. Pursuant to 35 Ill. Adm. Code 212.301 and 212.314, no person shall cause or allow the emission of fugitive particulate matter from any process, including any material handling or storage activity, that is visible by an observer looking generally overhead at a point beyond the property line of the source unless the wind speed is greater than 40.2 kilometers per hour (25 miles per hour), pursuant to 35 Ill. Adm. Code 212.301 and 212.314.
- d. Pursuant to 35 Ill. Adm. Code 212.321(a), no person shall cause or allow the emission of particulate matter into the atmosphere in any one hour period from any new process emission unit which, either alone or in combination with the emission of particulate matter from all other similar process emission units for which construction or modification commenced on or after April 14, 1972, at a source or premises, exceeds the allowable emission rates specified in subsection (c) of 35 Ill. Adm. Code 212.321.
- 4. Pursuant to 35 Ill. Adm. Code 214.301, no person shall cause or allow the emission of sulfur dioxide into the atmosphere from any process emission unit to exceed 2000 ppm.
- 5a. Pursuant to 35 Ill. Adm. Code 215.301, no person shall cause or allow the discharge of more than 8.0 lbs/hour of organic material into the atmosphere from any emission unit. If no odor nuisance exists then this limitation shall only apply to photochemically reactive material as defined in 35 Ill. Adm. Code 211.4690.
- b. In the event that the operation of this source results in an odor nuisance, the Permittee shall take appropriate and necessary actions to minimize odors, including but not limited to, changes in raw material or installation of controls, in order to eliminate the nuisance.
- 6a. The baghouse shall be in operation at all times when the associated drum dryer is in operation and emitting air contaminants.
- b. The Permittee shall follow good operating practices for the baghouse, including periodic inspection, routine maintenance and prompt repair of defects.
- 7a. The drum mixer and drum dryer shall only be operated with natural and propane gas as the fuel. The use of any other fuel in the drum mixer and drum dryer requires that the Permittee first obtain a construction permit from the Illinois EPA and then perform stack testing to verify compliance with all applicable requirements.

- b. Boilers and tank heaters associated with the drum-mix asphalt plant shall only be operated with natural and propane gas as the fuels.
- 8a. Emissions and operation of the asphalt plant shall not exceed the following limits:

- i. Asphalt Production Limits:

- iii. Emissions from Asphalt Silos Loading and Truck Loadout:

- iv. These limits are based on the maximum asphalt production and standard emission factors (Tables 11.1-3, 11.1-7, 11.1-8, and 11.1-14, AP-42, Volume I, Fifth Edition, Update 2001, December 2000).
- b. This permit is issued based on negligible emissions of VOM from the three asphalt storage tanks. For this purpose, emissions from all such sources shall not exceed nominal emission rates of 0.1 lb/hour and 0.44 tons/year total.
- c. Compliance with annual limits shall be determined on a monthly basis from the sum of the data for the current month plus the preceding 11 months (running 12 month total).
- 9a. Pursuant to 35 Ill. Adm. Code 212.107, 212.109, and 212.110, testing for particulate matter emissions shall be performed as follows:

- i. For both fugitive and nonfugitive particulate matter emissions, a determination as to the presence or absence of visible emissions from emission units shall be conducted in accordance with Method 22, 40 CFR part 60, Appendix A, incorporated by reference in 35 Ill. Adm. Code 212.113, except that the length of the observing period shall be at the discretion of the observer, but not less than one minute. This Condition shall not apply to 35 Ill. Adm. Code 212.301.
 - ii. Except as otherwise provided in 35 Ill. Adm. Code Part 212, and except for the methods of data reduction when applied to 35 Ill. Adm. Code 212.122 and 212.123, measurements of opacity shall be conducted in accordance with Method 9, 40 CFR Part 60, Appendix A, and the procedures in 40 CFR 60.675(c) and (d), if applicable, incorporated by reference in 35 Ill. Adm. Code 212.113, except that for roadways and parking areas the number of readings required for each vehicle pass will be three taken at 5-second intervals. The first reading shall be at the point of maximum opacity and second and third readings shall be made at the same point, the observer standing at right angles to the plume at least 15 feet away from the plume and observing 4 feet above the surface of the roadway or parking area. After four vehicles have passed, the 12 readings will be averaged.
 - iii. Measurement of particulate matter emissions from stationary emission units subject to 35 Ill. Adm. Code Part 212 shall be conducted in accordance with 40 CFR part 60, Appendix A, Methods 5, 5A, 5D, or 5E.
 - iv. The volumetric flow rate and gas velocity shall be determined in accordance with 40 CFR part 60, Appendix A, Methods 1, 1A, 2, 2A, 2C, 2D, 3, and 4.
 - v. Upon a written notification by the Illinois EPA, the owner or operator of a particulate matter emission unit subject to 35 Ill. Adm. Code Part 212 shall conduct the applicable testing for particulate matter emissions, opacity, or visible emissions at such person's own expense, to demonstrate compliance. Such test results shall be submitted to the Illinois EPA within thirty (30) days after conducting the test unless an alternative time for submittal is agreed to by the Illinois EPA.
- b. Testing required by Condition 9(a) shall be performed by a qualified independent testing service.
- 10a. The Permittee shall perform all applicable monitoring for the drum-mix asphalt plant as specified in 40 CFR 60.13.
 - b. Inspections of the affected drum-mix asphalt plant and control systems equipment and operations shall be performed as necessary but at least once per week when the affected drum-mix asphalt plant is in operation to confirm compliance with the requirements of this permit.

- 11a. The Permittee shall retain all applicable records for the drum-mix asphalt plant as specified by 40 CFR 60.7.
 - b. Pursuant to 35 Ill. Adm. Code 212.110(e), the owner or operator of an emission unit subject to 35 Ill. Adm. Code Part 212 shall retain records of all tests which are performed. These records shall be retained for at least three (3) years after the date a test is performed.
 - c. Records addressing use of good operating practices for the baghouse:
 - i. Operating logs for the drum-mix asphalt plant dryer baghouse, including operating data (pressure drop or stack condition), daily upon startup;
 - ii. Records for periodic inspection of the baghouse with date, individual performing the inspection, and nature of inspection; and
 - iii. Records for prompt repair of defects, with identification and description of defect, effect on emissions, date identified, date repaired, and nature of repair.
 - d. The Permittee shall maintain records of the following items:
 - i. Asphalt concrete production (tons/month and tons/year);
 - ii. Fuel Usage Records:
 - A. Propane usage (gallons/month and gallons/year); and
 - B. Natural gas usage (mmscf/month and mmscf/year).
 - iii. Monthly and Annual CO, NO_x, PM, SO₂, and VOM emissions from the drum-mix asphalt plant shall be maintained, based on asphalt production, fuel consumption, and the applicable emission factors, with supporting calculations.
 - e. All records and logs required by this permit shall be retained at a readily accessible location at the source for at least five (5) years from the date of entry and shall be made available for inspection and copying by the Illinois EPA and USEPA upon request. Any records retained in an electronic format (e.g., computer storage device) shall be capable of being retrieved and printed on paper during normal source office hours so as to be able to respond to the Illinois EPA or USEPA request for records during the course of a source inspection.
- 12a. The Permittee shall submit all applicable reports for the drum-mix asphalt plant as specified in 40 CFR 60.7 and 60.19.

- b. Pursuant to 35 Ill. Adm. Code 212.110(d), a person planning to conduct testing for particulate matter emissions to demonstrate compliance shall give written notice to the Illinois EPA of that intent. Such notification shall be given at least thirty (30) days prior to the initiation of the test unless a shorter period is agreed to by the Illinois EPA. Such notification shall state the specific test methods from 35 Ill. Adm. Code 212.110 that will be used.
 - c. If there is an exceedance of or a deviation from the requirements of this permit as determined by the record required by this permit, the Permittee shall submit a report to the Agency's Compliance and Systems Management Section in Springfield, Illinois within 30 days after the exceedance. The report shall include the emissions released in accordance with the recordkeeping requirements, a copy of the relevant records, and a description of the exceedance or deviation and efforts to reduce emissions and future occurrences.

Attachment A - Emissions Summary

This attachment provides a summary of the maximum emissions from the asphalt plant operating in compliance with the requirements of this federally enforceable permit. In preparing this summary, the Illinois EPA used the annual operating scenario which results in maximum emissions from such a plant. The resulting maximum emissions are below the levels, e.g., 100 tons per year of carbon monoxide at which this source would be considered a major source for purposes of the Clean Air Act Permit Program. Actual emissions from this source will be less than predicted in this summary to the extent that less material is handled and control measures are more effective than required in this permit.
