

FINDINGS AND ORDERS

The Director of Environmental Protection, having considered in compliance with the Administrative Procedure Act the adoption, in final form, of the proposed amended rules of the Ohio Administrative Code cited above, finds:

1. That due notice of a public hearing in this matter pursuant to the Administrative Procedure Act was given, that a public hearing was held on January 7, 2011, in Columbus, Ohio, and that all interested persons were afforded the opportunity to be heard; and

2. That upon due consideration, the rescission of the existing rules of the Administrative Code and the adoption, in final form, of the new and proposed rules of the Ohio Administrative Code cited above, is reasonable and lawful and within the purview of authority provided by law.

It is therefore

ORDERED that amended rules 3745-18-03 to 3745-18-10, 3745-18-12 to 3745-18-20, 3745-18-22 to 3745-18-26, 3745-18-28 to 3745-18-35, 3745-18-37 to 3745-18-39, 3745-18-41 to 3745-18-47, 3745-18-49, 3745-18-51, 3745-18-52, 3745-18-54 to 3745-18-57, 3745-18-61 to 3745-18-66, 3745-18-68 to 3745-18-72, 3745-18-74 to 3745-18-77, 3745-18-81 to 3745-18-89 and 3745-18-91 to 3745-18-93 of the Ohio Administrative Code be adopted in final form, that existing rules 3745-18-11, 3745-18-21, 3745-18-27, 3745-18-36, 3745-18-40, 3745-18-48, 3745-18-50, 3745-18-58 to 3745-18-60, 3745-18-67, 3745-18-73, 3745-18-79 and 3745-18-94 of the Ohio Administrative Code be rescinded, and that new rules 3745-18-11, 3745-18-21, 3745-18-27, 3745-18-36, 3745-18-40, 3745-18-48, 3745-18-50, 3745-18-58 to 3745-18-60, 3745-18-67, 3745-18-73, 3745-18-79 and 3745-18-94 of the Ohio Administrative Code be adopted in final form.

It is further

ORDERED that the effective date of said new, amended, and rescinded rules shall be ~~FEB 17 2011~~.


ORDERED that copies of these Findings and Orders and certified copies of said amended rules, in final form, shall be filed with the Secretary of State, the Joint Committee on Agency Rule Review, the Legislative Services Commission, and the Department of Development's Office of Small and Developing Business, as required by law.

APPEAL RIGHTS

Notice is hereby given that this action of the Director is final and may be appealed to the Environmental Review Appeals Commission pursuant to Section 3745.04 of the Ohio Revised Code. The appeal must be in writing and set forth the action complained of and the grounds upon which the appeal is based. The appeal must be filed with the Commission within thirty (30) days after notice of the Director's action. The appeal must be accompanied by a filing fee of \$70.00 which the Commission, in its discretion, may reduce if by affidavit you demonstrate that payment of the full amount of the fee would cause extreme hardship.

Notice of the filing of the appeal shall be filed with the Director within three (3) days of filing with the Commission. Ohio EPA requests that a copy of the appeal be served upon the Ohio Attorney General's Office, Environmental Enforcement Section.
