On May 2, 2011, the Environmental Protection Agency (EPA), Region 6 Compliance Assurance and Enforcement Division issued a Finding of Violation and Opportunity to Confer to White Stallion Energy Center, LLC (WSEC) regarding the inclusion of a Plant-Wide Applicability Limit in Permit Nos. 86088/PSD-TX-1160/PAL 26/HAP 28 (the Permit) for the planned WSEC in Matagorda County, Texas. On February 22, 2012, the Texas Commission on Environmental Quality (TCEQ) Commissioners decided to accept new evidence as part of a judicial remand of the Permit. While these proceedings are taking place, Region 6 believes this is a good opportunity for the PAL permit to be withdrawn, and the PAL provisions removed from the Permit. We have enclosed a courtesy copy of our letter to Mr. Randy Bird at White Stallion Energy Center regarding this matter.

While this letter is specific to the existing White Stallion PAL permit, we look forward to resolution of remaining concerns expressed in EPA letters dated April 14, 2009, April 20, 2009, February 10, 2010, September 29, 2010, and January 31, 2012.

On May 2, 2011, the U.S. Environmental Protection Agency (EPA), Region 6 Compliance Assurance and Enforcement Division issued a Finding of Violation and Opportunity to Confer to White Stallion Energy Center, LLC (WSEC) regarding the inclusion of a Plant-Wide Applicability Limit in Permit Nos. 86088/PSD-TX-1160/PAL 26/HAP 28 (the Permit) for the planned WSEC in Matagorda County, Texas. Further, at our meeting on June 7, 2011, we expressed our concerns regarding the PAL provision of your Permit and you expressed a willingness to consider the removal of the PAL provisions from your permit. Given the recent decision by the Texas Commission on Environmental Quality (TCEQ) Commissioners to accept new evidence as part of a judicial remand of your Permit, we believe that now is a good opportunity to request from TCEQ that the PAL permit be withdrawn, and the PAL provisions be removed from the Permit. We appreciate your efforts to address this violation and take the necessary steps to achieve a SIP compliant New Source Review permit.

While this letter is specific to the White Stallion PAL permit, we look forward to resolution of remaining concerns expressed in EPA letters dated April 14, 2009, April 20, 2009, February 10, 2010, September 29, 2010, and January 31, 2012.
