Subject: Minor Revision to Major Facility Review Permit for Facility # A2266

Dear Ms. Jordan:

This is to advise you that the Bay Area Air Quality Management District is proposing a minor revision to the Major Facility Review Permit for Browning-Ferris Industries of CA, Inc. (Facility Number A2266), and is submitting the permit to EPA for its 45-day review period.

The main purpose of this proposed minor permit revision is to incorporate alterations to the landfill gas collection system that were approved pursuant to NSR Application # 23391 into the MFR Permit for Site # A2266. The District is also updating regulatory citations and amendment dates, clarifying requirements, and correcting errors.

This proposed revision will not result in any emission increases. This revision is minor pursuant to BAAQMD Regulation 2-6-215 and will be effective immediately. The permit will be formally re-issued after EPA review. This revision is not subject to public comment and therefore, requires no public notice.
