NOTICE OF PROPOSED RENEWAL TITLE V PERMIT

The South Coast Air Quality Management District (SCAQMD) is the air pollution control agency for all of Orange County and portions of Los Angeles, Riverside and San Bernardino Counties. Rule 3006 requires that the SCAQMD publish this notice prior to the renewal of a Title V permit previously issued to the facility listed below:

The facility operates 10 natural gas fired engines, 2 natural gas fired heaters, gas odorizing and crude storage equipment, a vapor recovery system, and a flare used in the storage and transport of natural gas and crude oil.

Pursuant to Title V of the federal Clean Air Act and the SCAQMD Rule 3004(f), a Title V permit shall expire five years from the date of issuance unless such permit has been renewed. Accordingly, this facility has submitted a Title V renewal application and requested the SCAQMD to renew their Title V permits. The proposed permit incorporates updates to the facility information provided in the facility's Title V renewal application and all rules and regulations that are currently applicable to this facility.

The proposed permit is available for public review at the SCAQMD, 21865 Copley Dr., Diamond Bar, CA, and at the Valencia Library, 23743 Valencia Blvd., Valencia, CA 91355. The public may request the SCAQMD to conduct a public hearing on the proposed permit by submitting a Hearing Request Form (Form 500-G) to Mr. Perri at the above SCAQMD address. The SCAQMD will hold a public hearing if there is evidence that the proposed permit is not correct or is not adequate to ensure compliance with regulatory requirements, and a hearing will likely provide additional information that will affect the drafting and/or issuance of the permit.
