NOTICE OF PROPOSED RENEWAL TITLE V PERMIT

The South Coast Air Quality Management District (SCAQMD) is the air pollution control agency for all of Orange County and portions of Los Angeles, Riverside and San Bernardino Counties. Rule 3006 requires that the SCAQMD publish this notice prior to the renewal of a Title V permit previously issued to the facility listed below:

The facility operates 1 gas turbine and 2 steam boilers along with auxiliary equipment used in the production of electrical power and steam.

Pursuant to Title V of the federal Clean Air Act and the SCAQMD Rule 3004(f), a Title V permit shall expire five years from the date of issuance unless such permit has been renewed. Accordingly, this facility has submitted a Title V renewal application and requested the SCAQMD to renew their Title V permits. The proposed permit incorporates updates to the facility information provided in the facility's Title V renewal application and all rules and regulations that are currently applicable to this facility.

The proposed permit is available for public review at the SCAQMD, 21865 Copley Dr., Diamond Bar, CA, and at the Santa Fe Springs City Library, 11700 Telegraph Road, Santa Fe Springs, CA 90670. The proposed permit can also be viewed at <http://www3.aqmd.gov/webappl/publicnotices2/> by entering the facility's ID number. Information regarding the facility owner's

compliance history submitted to the SCAQMD pursuant to California Health & Safety Code Section 42336, or otherwise known to the SCAQMD based on credible information, is also available from the SCAQMD for public review. **Anyone wishing to comment on the issuance of the proposed permit should submit their comments in writing by October 30, 2014. The public may request the SCAQMD to conduct a public hearing on the proposed permit by submitting a Hearing Request Form (Form 500-G) to Mr. Perri at the above SCAQMD address. The SCAQMD will hold a public hearing if there is evidence that the proposed permit is not correct or is not adequate to ensure compliance with regulatory requirements, and a hearing will likely provide additional information that will affect the drafting and/or issuance of the permit.
