The public comment period on the proposed renewal permit ended on May 10, 2010 and EPA review period ended on May 6, 2010. Two comments were received from the EPA. The first comment was related to the applicability of section 63.3163 of 40 CFR Part 63, Subpart IIII, National Emissions Standards for Hazardous Air Pollutants: Surface Coating of Automobile and Light Duty Trucks. The section 63.3163 requirements have been added to the permit. The second comment was related to 40 CFR Part 68, Chemical Accident Prevention Provisions. Currently, NUMMI is not subject to this requirement. EPA requested that the permit include a requirement that the facility re-evaluate the applicability of Part 68 whenever a process change is made at the facility or if the regulation is amended. This requirement was added to the permit.

No comments were received from the public, ARB, or the facility.

The District has decided to issue the renewal permit.
