

## NOTICE INVITING WRITTEN PUBLIC COMMENTS

**NOTICE** is hereby given that the Air Pollution Control Officer of the Bay Area Air Quality Management District (District) is reopening the Major Facility Review Permit for the following facility:

The purpose of this reopening is to add the requirements related to the NESHAP for Municipal Solid Waste Landfills (40 CFR 63, Subpart AAAA) that was promulgated on January 16, 2003. In addition to the reopening action, the District is proposing administrative amendments and minor revisions to this permit in order to update contact information and collection system descriptions, update citations and dates based on SIP approvals and other regulatory changes, correct errors, and clarify permit language.

This permit was originally issued on November 28, 2001 and expires on October 31, 2006. Reopening this permit is required by Regulation 2, Rule 6 and by EPA's Title V regulations, because the expiration date for the permit is more than three years from the date of promulgation of the standard. All changes to the permit are clearly shown in ~~strikeout~~/underline format.

The reopening and other revisions are expected to have no impact on emissions.

The Air Pollution Control Officer invites written comment on the proposed changes to the permit. Comments must be received by August 27, 2004. The public may also request a public hearing for this reopening.

Major Facility Review Permits are also subject to review and approval by US EPA. If US EPA has not objected to a proposed permit and the District has not addressed a public comment in a satisfactory manner, the public may petition US EPA, Region IX, Operating Permits Section at 75 Hawthorne Street, San Francisco, CA 94105, within 60 days after the end of US EPA's review, to reconsider the decision to not object to the permit.
