I. PROPOSAL

SFPP, L.P. was issued a Title V permit on April 20, 1999. As required by District Rule 2520, the applicant is requesting a permit renewal. The existing Title V permit shall be reviewed and modified to reflect all applicable District and federal rules updated, removed, or added since the issuance of the initial Title V permit.

The purpose of this evaluation is to provide the legal and factual basis for all updated applicable requirements and to determine if the facility will comply with these updated requirements. It also specifically identifies all additions, deletions, and/or changes made to permit conditions or equipment descriptions.

II. FACILITY LOCATION

SFPP, L.P. is located at 4149 South Maple Avenue in Fresno, California.

III. EQUIPMENT LISTING

A detailed facility printout listing all permitted equipment at the facility is included as Attachment C.

IV. GENERAL PERMIT TEMPLATE USAGE

The applicant is requesting to use the following model general permit Templates:

A. Template SJV-UM-0-3 Facility Wide Umbrella

The applicant utilized template No. SJV-UM-0-2, Facility Wide Umbrella on the initial Title V permit. This template has been superseded by template SJV-UM-0-3 Facility Wide Umbrella, therefore the facility wide template conditions will be updated accordingly.

V. SCOPE OF EPA AND PUBLIC REVIEW

Segments of the proposed Operating Permit are based on model general permit templates that have been previously subject to EPA and public review. The terms and conditions from the model general permit templates are included in the proposed permit and are not subject to further EPA and public review.

For permit applications utilizing model general permit templates, public and agency comments on the District's proposed actions are limited to the applicant's eligibility for model general permit template, applicable requirements not covered by the model general permit template, and the applicable procedural requirements for issuance of Title V Operating Permits.

The following permit conditions have been updated to reflect the updated permit templates. Their underlying applicable requirements originate from model general permit templates and are not subject to further EPA and Public review:

VIII. REQUIREMENTS NOT FEDERALLY ENFORCEABLE

For each Title V source, the District issues a single permit that contains the Federally Enforceable requirements, as well as the District-only requirements. The District-only requirements are not a part of the Title V Operating Permits. The terms and conditions that are part of the facility's Title V permit are designated as "Federally Enforceable Through Title V Permit".

For this facility, the following are not federally enforceable and will not be discussed in further detail:

B. Rules Not Updated

District Rule 4102, Nuisance (as amended December 17, 1992)

- Condition 42 of the requirements of the facility wide requirements, C-1077-0-2, is based on this rule and is not Federally Enforceable through Title V.

IX. PERMIT REQUIREMENTS

The purpose of this evaluation is to review changes to federally enforceable requirements; therefore, this compliance section will only address rules that have been amended or added since the issuance of the initial Title V permit.

A. District Rule 2201 - New and Modified Stationary Source Review Rule

District Rule 2201 has been amended since this facility's initial Title V permit was issued. This Title V permit renewal does not constitute a modification per section 3.26, defined as an action including at least one of the following items:

- 1) Any change in hours of operation, production rate, or method of operation of an existing emissions unit, which would necessitate a change in permit conditions.
- 2) Any structural change or addition to an existing emissions unit which would necessitate a change in permit conditions. Routine replacement shall not be considered to be a structural change.
- 3) An increase in emissions from an emissions unit caused by a modification of the Stationary Source when the emissions unit is not subject to a daily emissions limitation.
- 4) Addition of any new emissions unit which is subject to District permitting requirements.
- 5) A change in a permit term or condition proposed by an applicant to obtain an exemption from an applicable requirement to which the source would otherwise be subject.

Therefore, the updated requirements of this rule are not applicable at this time.

B. District Rule 2520 – Federally Mandated Operating Permits

Greenhouse Gas (GHG) Requirements:

There are no federally applicable Greenhouse Gas (GHG) requirements for this source. It should be noted that the Mandatory Greenhouse Gas Reporting rule (40CFR Part 98) is not included in the definition of an applicable requirement within Title V (per 40CFR 71.2). Therefore, there will be no further discussion of GHG in this evaluation.

C. District Rule 4623 – Storage of Organic Liquids

The purpose of this rule is to limit volatile organic compounds (VOC) emissions from the storage of organic liquids.

Section 2.0 (Applicability)

This rule applies to any tank with a design capacity of 1,100 gallons or greater used to store organic liquid with a true vapor pressure of 0.5 psia or greater.

Section 3.0 (Definitions)

Section 3.0 defines key vocabulary that is used throughout the rule. The following conditions ensure the requirements of this section are met:

- Condition 15 is has been placed on permit unit C-1077-4-3 in order to ensure the definition of a gas-tight condition is clearly defined.
- Condition 20 is has been placed on permit units C-1077-5-7, 6-4, -8-4, -9-4, -10-4, -11-6, -12-4, -14-5, -15-3, -16-4, and -17-5 in order to ensure the definition of a gas-tight condition is clearly defined.
- Condition 15 is has been placed on permit unit C-1077-7-4 in order to ensure the definition of a gas-tight condition is clearly defined.
- Condition 15 is has been placed on permit units C-1077-18-4, -19-5, -20-4, -21-4, and -50-2 in order to ensure the definition of a gas-tight condition is clearly defined.
- Condition 5 is has been placed on permit unit C-1077-22-4 in order to ensure the definition of a gas-tight condition is clearly defined.
- Condition 8 is has been placed on permit unit C-1077-23-4 in order to ensure the definition of a gas-tight condition is clearly defined.
- Condition 8 is has been placed on permit unit C-1077-33-3 in order to ensure the definition of a gas-tight condition is clearly defined.

- Condition 4 is has been placed on permit units C-1077-34-2, -35-2, -36-2 and -37-2 in order to ensure the definition of a gas-tight condition is clearly defined.

Section 5.0 (Requirements)

5.1 This section of the rule outlines the VOC control system requirements for organic liquid storage tanks. The following conditions ensure the requirements of this section are met:

- Compliance is enforced by condition 2 of the requirements for permit unit C-1077-4-3.
- Compliance is enforced by condition 5 of the requirements for permit units C-1077-5-7, 6-4, -8-4, -9-4, -10-4, -11-6, -12-4, -14-5, -15-3, -16-4, and -17-5.
- Compliance is enforced by condition 2 of the requirements for permit unit C-1077-7-4.
- Compliance is enforced by condition 2 of the requirements for permit units C-1077-18-4, -19-5, -20-4, , -21-4, -22-4 and -50-2.
- Compliance is enforced by condition 1 of the requirements for permit unit C-1077-23-4.
- Compliance is enforced by condition 1 of the requirements for permit unit C-1077-33-3.
- Compliance is enforced by condition 2 of the requirements for permit unit C-1077-45-3.

5.2 Section 5.2 outlines the requirements for pressure relief valves. The following conditions ensure the requirements of this section are met:

- Compliance is enforced by condition 14 of the requirements for permit unit C-1077-4-3.
- Compliance is enforced by condition 14 of the requirements for permit unit C-1077-7-4.
- Compliance is enforced by condition 17 of the requirements for permit unit C-1077-13-6.
- Compliance is enforced by condition 14 of the requirements for permit units C-1077-18-4, -19-5, -20-4, -21-4 and -50-2.
- Compliance is enforced by condition 4 of the requirements for permit units C-1077-22-4.
- Compliance is enforced by condition 7 of the requirements for permit unit C-1077-23-4.
- Compliance is enforced by condition 7 of the requirements for permit unit C-1077-33-3.

- Compliance is enforced by condition 1 of the requirements for permit units C-1077-34-2, -35-2, -36-2, and -37-2.

5.3 This section of rule 4623 outlines the requirements and specifications for external floating roof tanks. The following conditions ensure the requirements of this section are met:

- Compliance is enforced by conditions 3 thru 13 of the requirements for permit unit C-1077-4-3.
- Compliance is enforced by conditions 6 thru 18 of the requirements for permit units C-1077-5-7, 6-4, -8-4, -9-4, -10-4, -11-6, -12-4, -14-5, -15-3, -16-4, and -17-5.
- Compliance is enforced by conditions 3 thru 12 of the requirements for permit unit C-1077-7-4.
- Compliance is enforced by conditions 6 thru 17 of the requirements for permit unit C-1077-13-6.
- Compliance is enforced by conditions 3 thru 13 of the requirements for permit units C-1077-18-4, -19-5, -20-4, -21-4 and -50-2.
- Compliance is enforced by conditions 3 and 11 of the requirements for permit unit C-1077-22-4.
- Compliance is enforced by conditions 2, 3, 4, 5 and 12 of the requirements for permit unit C-1077-23-4.
- Compliance is enforced by conditions 2, 3, 4, 5, 6 and 15 of the requirements for permit unit C-1077-33-3.

5.5 Section 5.5 outlines floating roof deck fitting requirements. The following conditions ensure the requirements of this section are met:

- Compliance is enforced by conditions 16 thru 21 of the requirements for permit unit C-1077-4-3.
- Compliance is enforced by conditions 19 thru 31 of the requirements for permit units C-1077-5-7, 6-4, -8-4, -9-4, -10-4, -11-6, -12-4, -14-5, -15-3, -16-4, and -17-5.
- Compliance is enforced by conditions 16 thru 21 of the requirements for permit unit C-1077-7-4.
- Compliance is enforced by conditions 19 thru 24 of the requirements for permit unit C-1077-13-6.
- Compliance is enforced by conditions 16 thru 21 of the requirements for permit units C-1077-18-4, -19-5, -20-4, -21-4 and -50-2.
- Compliance is enforced by conditions 12 thru 18 of the requirements for permit units C-1077-22-4.
- Compliance is enforced by conditions 13 thru 19 of the requirements for permit units C-1077-23-4.

- Compliance is enforced by conditions 16, 18, 19, and 20 of the requirements for permit units C-1077-33-3.

5.6 Section 5.6 describes the specifications for vapor recovery systems. The following conditions ensure the requirements of this section are met:

Section 6.0 (Administrative Requirements)

6.1 Section 6.1 outlines the administrative requirements for inspections of internal floating roof tanks. The following conditions ensure the requirements of this section are met:

- Compliance is enforced by conditions 22, 23 and 24 of the requirements for permit unit C-1077-4-3.
- Compliance is enforced by conditions 32 thru 34 of the requirements for permit units C-1077-5-7 and C-1077-6-4.
- Compliance is enforced by conditions 1, 23 and 24 of the requirements for permit unit C-1077-7-4.
- Compliance is enforced by conditions 32 thru 34 of the requirements for permit units C-1077-8-4, -9-4, -10-4 and -11-6.
- Compliance is enforced by conditions 25, 26 and 27 of the requirements for permit unit C-1077-13-6.
- Compliance is enforced by conditions 32 thru 34 of the requirements for permit units C-1077-12-4, -14-5, -15-3, -16-4 and -17-5.
- Compliance is enforced by conditions 1, 22, 23, and 24 of the requirements for permit units C-1077-18-4, -19-5, -20-4, -21-4 and -50-2.

- Compliance is enforced by condition 12 of the requirements for permit unit C-1077-24-3.
- Compliance is enforced by conditions 27, 28, 29 and 30 of the requirements for permit unit C-1077-33-3.
- Compliance is enforced by condition 17 of the requirements for permit unit C-1077-42-5.
- Compliance is enforced by conditions 6 and 7 of the requirements for permit unit C-1077-45-3.

- Compliance is enforced by condition 3 of the requirements for permit unit C-1077-43-7.
- Compliance is enforced by condition 3 of the requirements for permit unit C-1077-44-3.

6.4 Section 6.4 specifies the requirements for testing procedures for the requirements of Rule 4623. The following conditions ensure the requirements of this section are met:

- Compliance is enforced by condition 25 of the requirements for permit units C-1077-4-3 and C-1077-7-4.
- Compliance is enforced by condition 46 of the requirements for permit units C-1077-6-4, 8-3, 9-4, 10-3, -11-6, -14-5, 15-3, -16-4 and -17-5.
- Compliance is enforced by condition 24 of the requirements for permit
- Compliance is enforced by condition 28 of the requirements for permit unit C-1077-13-6.
- Compliance is enforced by condition 25 of the requirements for permit units C-1077-18-4, -19-5, -20-23, -21-4, -23-4.
- Compliance is enforced by condition 24 of the requirements for permit unit C-1077-22-4.
- Compliance is enforced by conditions 3 and 4 of the requirements for permit unit C-1077-45-3.
- Compliance is enforced by condition 26 of the requirements for permit unit C-1077-33-3.

D. District Rule 4624—Transfer of Organic Liquid

District Rule 4624 was last amended on December 20, 2007, and the current version was approved into the SIP on October 15, 2009.

The purpose of this rule is to limit VOC emissions from the transfer of organic liquids.

Section 5.1 requires that for a Class 1 organic liquid transfer facility, the emission of VOC from the transfer operation shall not exceed 0.08 pounds per 1,000 gallons of organic liquid transferred; and bottom loading and vapor control systems shall be used. The following conditions ensure the requirements of this section are met:

- Compliance is enforced by condition 5 of the requirements for permit unit C-1077-13-2.

- Compliance is enforced by condition 16 of the requirements for permit unit C-1077-26-9, -51-2, '-27-9, '28-9, 29-9, '38-9 and '42-5.

Section 5.2 requires that organic liquid transfer facility shall prevent the release to the atmosphere of at least 95 percent by weight of the VOC displaced during organic liquid transfers and use one of the following systems listed in Sections 5.2.1 or 5.2.2.

- Compliance is enforced by condition 1 of the requirements for permit unit C-1077-26-9, -51-2, '-27-9, '28-9, 29-9, '38-9 and '42-5.

Section 5.4 requires that the vapor collection and control system shall operate such that the pressure in the delivery tank being loaded does not exceed 18 inches water column pressure and six (6) inches water column vacuum. This section shall not apply to the transfer of liquefied petroleum gas.

- Compliance is enforced by condition 11 of the requirements for permit unit C-1077-42-5.

Section 5.5 requires that all delivery tanks which previously contained organic liquids with a TVP of 1.5 psia or greater at the storage container's maximum organic liquid storage temperature shall be filled only at transfer facilities satisfying Sections 5.1, 5.2, or 5.4, as applicable.

- Compliance is enforced by condition 2 of the requirements for permit unit C-1077-42-5.

Section 5.6 requires that the transfer rack and vapor collection equipment shall be designed, installed, maintained and operated such that there are no leaks and no excess organic liquid drainage at disconnections.

- Compliance is enforced by condition 16 of the requirements for permit unit C-1077-13-2.
- Compliance is enforced by conditions 11, 12, 13, 14 & 15 of the requirements for permit units C-1077-26-9, -51-2, '-27-9, '28-9, 29-9 & -'38-9.

Section 5.7 requires that the construction of any new top loading facility or the reconstruction, as defined in 40 CFR 60.15, or the expansion of any existing top loading facility with top loading equipment shall not be allowed.

- Compliance is enforced by condition 2 of the requirements for permit unit C-1077-26-9, -51-2, '-27-9, '28-9, 29-9 & '-38-9.

Section 6.1.3 requires that an operator subject to any part of Section 5.0 shall keep records of daily liquid throughput and the results of any required leak inspections.

Section 6.1.4 requires that records required under sections 6.1.3 shall be retained for a minimum of five years and shall be made readily available to the APCO, ARB, or EPA during normal business hours and submitted upon request to the APCO, ARB, or EPA.

- Compliance is enforced by condition 7 of the requirements for permit unit C-1077-13-2.
- Compliance is enforced by condition 14 of the requirements for permit unit C-1077-42-5.

Section 6.2 requires that the operator of any Class 1 or Class 2 organic liquid transfer facility shall perform an initial source test of the VOC emission control system in accordance with the method prescribed in Section 6.3.2 to determine compliance with Section 5.1 and 5.2, as applicable.

- Compliance is enforced by condition 8 of the requirements for permit unit C-1077-13-2.
- Compliance is enforced by condition 8 & 9 of the requirements for permit unit C-1077-42-5.

Section 6.3.1 requires that analysis of halogenated exempt compounds shall be by ARB Method 432.

- Compliance is enforced by condition 8 of the requirements for permit unit C-1077-26-9, -51-2, '-27-9, '28-9, 29-9 & '-38-9.

Section 6.3.2 requires that compliance with sections 5.1 and 5.2 shall be determined using 40 CFR 60.503 "Test Methods and Procedures" and EPA Methods 2A, 2B, 25A and 25B and ARB Method 422, or ARB Test Procedure

- Compliance is enforced by condition 9 of the requirements for permit unit C-1077-26-9, -51-2, '-27-9, '28-9, 29-9 & '-38-9.

E. District Rule 4701 – Internal Combustion Engines – Phase 1

The purpose of this rule is to limit the emissions of nitrogen oxides (NO_x), carbon monoxide (CO), and volatile organic compounds (VOC) from internal combustion engines. Except as provided in Section 4.0, the provisions of this rule apply to any internal combustion engine, rated greater than 50 bhp, which requires a Permit to Operate (PTO).

Pursuant to Section 7.5.2.3 of District Rule 4702, as of June 1, 2006 District Rule 4701 is no longer applicable to diesel-fired emergency standby, emergency IC engines or engines subject to Section 5.1 of 4702. Therefore, the permitted units will comply with the requirements of District Rule 4702 and no further discussion is required.

F. District Rule 4702–Internal Combustion Engines–Phase 2

The purpose of this rule is to limit the emissions of nitrogen oxides (NO_x), carbon monoxide (CO), and volatile organic compounds (VOC) from internal combustion engines. The rule was amended on January 18, 2007 to address the following: The definition of Certified Compression-Ignited Engine was modified to include a Code of Federal Regulation citation. Exemption was added for engines used in retracting arresting gear cables used to stop military naval aircraft after landing. A compliance deadline for engines used exclusively in agricultural operation was extended for one year. Engines operated with an APCO certified exhaust control system were exempted from submitting an emission control plan. Certified compression ignition engines were exempted from compliance testing. A portable NO_x analyzer was allowed for Agriculture Operation (AO) spark-ignited engines to initially show compliance with the emission standards until a source test can be arranged. Representative testing for spark-ignited engines were allowed. A District certification program was established to verify the control efficiency of exhaust control systems.

The following permit requirements ensure compliance with this rule:

Section 3.15 outlines the requirements for an Emergency Standby Engine: an internal combustion engine which operates as a temporary replacement for primary mechanical or electrical power during an unscheduled outage caused by sudden and reasonably unforeseen natural disasters or sudden and reasonably unforeseen events beyond the control of the operator. An engine shall be considered to be an emergency standby engine if it is used only for the following purposes: (1) periodic maintenance, periodic readiness testing, or readiness testing during and after repair work; (2) unscheduled

outages, or to supply power while maintenance is performed or repairs are made to the primary power supply; and (3) if it is limited to operate 100 hours or less per calendar year for non-emergency purposes. An engine shall not be considered to be an emergency standby engine if it is used: (1) to reduce the demand for electrical power when normal electrical power line service has not failed, or (2) to produce power for the utility electrical distribution system, or (3) in conjunction with a voluntary utility demand reduction program or interruptible power contract. The following conditions ensure the requirements of this section are met:

- Compliance is enforced by conditions 9, 23 and 24 of the requirements for permit unit C-1077-1-4 and -2-4.

Section 4.2.1 outlines the requirements for an emergency standby engine as defined in Section 3.0 of this rule, and provided that it is operated with a no resettable elapsed operating time meter. In lieu of a no resettable time meter, the owner of an emergency engine may use an alternative device, method, or technique, in determining operating time provided that the alternative is approved by the APCO. The owner of the engine shall properly maintain and operate the time meter or alternative device in accordance with the manufacturer's instructions. The following conditions ensure the requirements of this section are met:

- Compliance is enforced by condition 13 of the requirements for permit unit C-1077-1-4 and -2-4.

Section 5.6 outlines the requirements for The owner of a non-AO spark-ignited engine subject to the requirements of Section 5.1 or any engine subject to the requirements of Section 8.0 shall comply with the requirements detailed in this section. The following conditions ensure the requirements of this section are met:

- Compliance is enforced by condition 22 of the requirements for permit unit C-1077-1-4 and -2-4.

Section 6.2.1 outlines the requirements for record keeping. Except for engines subject to Section 4.0, the owner of an engine subject to the requirements of Section 5.1 of this rule shall maintain an engine operating log to demonstrate compliance with this rule. This information shall be retained for a period of at least five years, shall be readily available, and be made available to the APCO upon request. The engine operating log shall include record keeping items as listed in this Section. The following conditions ensure the requirements of this section are met:

- Compliance is enforced by conditions 8 and 18 of the requirements for permit unit C-1077-1-4 and -2-4.
- Compliance is enforced by condition 11 of the requirements for permit unit C-1077-2-4.

G. 40 CFR Part 64-CAM

40 CFR Part 64 requires Compliance Assurance Monitoring (CAM) for units that meet the following three criteria:

- 1) the unit must have an emission limit for the pollutant;
- 2) the unit must have add-on controls for the pollutant; these are devices such as flue gas recirculation (FGR), baghouses, and catalytic oxidizers; and
- 3) the unit must have a pre-control potential to emit of greater than the major source thresholds.

There are no storage tanks at the facility which require CAM due to the listed criteria not being met. Below is a list of permits not subject to CAM requirements:

1. The following permits have no emissions limit, therefore not subject to CAM
 - a. C-1077-6-5, -8-4 thru -17-5, -39-3 thru -42-2, & -49-2
2. The following permits have no add on controls, therefore not subject to CAM
 - a. C-1077-1-4, -2-4, -13-6, -24-3, -26-9, -27-9, -28-9, -29-9, -34-2, -35-2, -36-2, -37-2, -38-9, -50-2 & -51-2
3. The following permits have no pre-control potential to emit greater than the major source threshold, therefore not subject to CAM
 - a. C-1077-4-3, -5-7, -7-4, -18-4 through -23-4 and -43-7 through -45-2
4. The thermal oxidizer (-3-12) controls emissions from all of the loading racks and triggers CAM. A continuous temperature recorder maintaining 900 degrees F assures compliance with this requirement through conditions 3 and 4.

H. 40 CFR 63 Subpart ZZZZ Requirements for Performance Tests

Subpart ZZZZ establishes national emission limitations and operating limitations for hazardous air pollutants (HAP) emitted from stationary reciprocating internal combustion engines (RICE) located at major and area sources of HAP emissions. This subpart also establishes requirements to demonstrate initial and continuous compliance with the

emission limitations and operating limitations . The following conditions ensure the requirements of this section are met:

- Compliance is enforced by conditions 3-9, 13 and 25 of the requirements for permit unit C-1077-1-4 and -2-4.

X. PERMIT SHIELD

A permit shield legally protects a facility from enforcement of the shielded regulations when a source is in compliance with the terms and conditions of the Title V permit. Compliance with the terms and conditions of the Operating Permit is considered compliance with all applicable requirements upon which those conditions are based, including those that have been subsumed.

By using the model general permit template listed in Section IV of this evaluation, the applicant has requested that a permit shield be issued for requirements addressed in the template. The basis for each permit shield is discussed in the Permit Shield section of each template.

A. Requirements Addressed by Model General Permit Templates

1. Model General Permit Template SJV-UM-0-3

By submitting Model General Permit Template SJV-UM-0-3 qualification form, the applicant has requested that a permit shield be granted for all the applicable requirements identified by the template. Therefore, the permit shields as granted in Model General Permit Template is included as conditions 39 and 40 of the facility-wide requirements (C-1077-0-2).

B. Requirements not Addressed by Model General Permit Templates

The applicant has requested and been granted permit shields for District Rule 4623 for storage tank permit units -6-5, -8-4 through -12-4, 14-5 through -17-5, -34-2 through -37-2. The applicant has requested and been granted permit shields for District Rule 4624 for loading rack permit units -26-9 through -29-9, -38-4, -42-5 and -51-2.
