NOTICE OF PROPOSED TITLE V RENEWAL PERMIT

The South Coast Air Quality Management District (AQMD) is proposing to renew the existing Title V permit that was previously issued to the following facility:

This is an existing facility applying for a renewal to their Title V permit. The facility manufactures a variety of plastic products for the commercial food services industry. This facility operates one injection molding process, one compression molding process, one internal combustion engine to generate compressed air, two silkscreen printing electric drying ovens, one burn-off furnace, four plastic size reduction grinders and one portable plasma arc cutter. Emissions from the above-described equipment are vented to one dust collector, and one cyclone and four bag-filters to control the PM emissions, and one afterburner to control the VOC emissions.

Pursuant to Title V of the federal Clean Air Act and AQMD Rule 3004(f), a Title V permit shall expire five years from the date of issuance unless such permit has been renewed. Accordingly, the above facility has submitted a Title V renewal application and requested the AQMD to renew their Title V permit. The proposed permit incorporates updates to the facility information provided in the facility's Title V renewal application and all rules and regulations that are currently applicable to the facility.

The proposed permit is available for public review at AQMD, 21865 Copley Dr., Diamond Bar, CA 91765 and at Huntington Beach Public Library, 7111 Talbert Ave., Huntington Beach, CA 92648. Information regarding the facility owner's compliance history submitted to the AQMD pursuant to California Health & Safety Code Section 42336, or otherwise known to the AQMD based on credible information, is also available from the AQMD for public review. Comments must be received by November 13, 2009. The AQMD will consider all public comments and may revise the Title V permit in accordance with AQMD rules and regulations.

The public may request AQMD to conduct a public hearing on the proposed permit by submitting a Hearing Request Form (Form 500-G) to Stephen Jiang at the above AQMD address. The AQMD will hold a public hearing if there is evidence that the proposed permit is not correct or is not adequate to ensure compliance with regulatory requirements, and a hearing will likely provide additional information that will affect the drafting and/or issuance of the permit.
